Most of the bears in the Southwest are black bears. Many of the people that are killed by these animals are hunters. It is not uncommon for hunters to be shot. Because of this, more than 90% of the compensated bear deaths in the state come from hunting. The State of New Mexico has outlawed the use of dead bear bait. Still, hunters who use this method are not required to submit photos or film of the activity in order to receive compensation. If you are accidentally injured or harmed by a bear, you will have to pursue any claims against the one who injured or harmed you. In most of these cases, the injured party can sue the person or corporation that was responsible for the injuries or damages they sustained.
